## **FFWPU is looking for our next Treasurer**

The trustee body is seen as a very important entity in charity law, maintaining the lawfulness and integrity of the charity concerned where all trustees are seen as equally important. There are however two positions on a trustee body which the supervisory authorities are particularly concerned about – the Chair of the Trustees and the Treasurer. There are 160,000 charities in the UK so there are 160,000 Treasurers. Through his or her work the Treasurer has a major opportunity to contribute to the good name and respect given to our charity and to protect its reputation.

In the FFWPU, the Treasurer

- Looks after the finances in terms of ensuring that appropriate accounting procedures and controls are in place as well as appropriate (lawful, professional) use of funds
- Participates in the process of preparation, presentation and approval of budgets, accounts and financial statements
- Prepares and presents understandable financial reports to a number of committees
- Ensures that the financial resources of the organisation meet its needs
- Liaises with relevant people about financial matters
- Oversees the preparation of the annual accounts by our external accountants before being passed to the independent auditor.
- Liaises with the auditor to ensure a smooth audit leading to a very satisfactory result.

Essential qualities for this role include:

- An already existing understanding of accounting procedures and controls in a charity or the aptitude and willingness to quickly learn about these
- A strong sense of responsibility and also loyalty to the aims of the FWWPU as Unificationist in good standing, capable of working well as a team player and a colleague to other trustees as well the trustee body's partners such as the Finance Committee and others, winning their respect and trust
- Strong attention to detail and the ability to develop a strong understanding of what is correct and what is not
- An ability to deal with public bodies such as the Charity Commission, banks, lawyers and auditors as well as our external accountants in Chippenham, which requires a certain minimum degree of maturity and self-confidence

- Pride in doing a good job to further the good name of the FFWPU by getting the charity's accounts audited and submitted well before established deadlines

This is a voluntary post. Full training is provided by the current Treasurer involving some book learning and shadowing of the current Treasurer through the process of completing the 2017 accounts audit as well as a number of other jobs.
