Dear Leaders and all Blessed Families,

As you remember, 2020 was a very special year in God's providence, as True Parents celebrated the opening of the era for the substantial Cheon Il Guk, as well as True Father's 100th birthday. At that time, Special Grace for CheonBo Registration was offered to all the members, but due to Covid, it could only be offered in Korea.

Now, as we prepare for the dedication of the Cheon Won Gung Cheon Il Sanctum, our True Parents have announced an extension of this Special Grace on a global level.

In the attached official memo, you will note that this is called the CheonBo Holy Wine Ceremony. Please do not be confused. This Holy Wine Ceremony is not just for those who wish to become CheonBo couples at this time, but this Holy Wine includes Special Grace forgiveness for everyone and is also the Holy Wine Ceremony for the Cheon Il Guk Registration Blessing, which is also being offered at this time for all those who have not yet participated since the year 2013.

Meaning of the Special Grace

The Special Grace given by the True Parents cleanses Cheon Il Guk citizens from any violation of heavenly laws they have consciously or unconsciously committed in front of Heavenly Parent related to matters of ethics, faith and the heart, such as negligent life of faith, drinking, smoking, apostasy, heresy, problems related to lineage, infringements of the heart, etc.

True Parents' special grace does not absolve from indemnities stemming from violating a Nation's positive laws or from harm or hurt caused to others.

3. Previously Married 1st gen. Couples
4. Blessed Children who married, but didn't receive the Blessing yet
5. Blessed Children and Intergenerational couples who incorrectly received a HTM Blessing
6. Single Person Blessing Candidates

Conditions of Devotion in order to participate in the Holy Wine Ceremony

A 40 day period of devotions needs to be offered from March 26 to May 4, 2023. This will consist of a bowing condition and Hoon Dok Hae, as well as a monetary donation based on the number 13. (Further details will be announced soon).

Additionally, all participants must submit a "Statement of Resolve" repenting for their past mistakes and expressing resolution for a new beginning (document attached below).

**Re.: Guidance on the Extension of Special Grace for CheonBo Registration in the Era of the
Firm Establishment of Cheon Il Guk**

May the Heavenly Parent and True Parents' blessings and love be with you all.

We would like to announce the extension of the "Special Grace for CheonBo Registration in the Era of the Firm Establishment of Cheon Il Guk" to blessed families and members throughout the world who were unable to attend the Special Grace of 2020 that was announced in the official memo FFWPUI 2020-010, due to the COVID-19 outbreak. In particular, this year 2023 is truly a year of blessing with the dedication of Cheon Won Gung Cheon Il Sanctum as well as True Father's 103rd and True Mother's 80th birthdays. Please guide all blessed families and members who meet these criteria to participate in the CheonBo Special Grace.

1. Meaning of the Special Grace

- A. The special grace that the True Parents of Heaven, Earth, and Humankind bequeath cleanses Cheon Il Guk citizens from any violation of heavenly law they have consciously or unconsciously committed in front of Heavenly Parent. These include matters of ethics, of faith and of the heart, such as negligent life of faith, drinking, smoking, apostasy, heresy, sexual fall or other sexual problems, and infringements of the heart.
- B. True Parents' special grace does not absolve us from the need to indemnify the violation of a nation's laws or the harm or hurt caused to others. Such indemnity conditions must be set and fulfilled by each person.

2. Standard for Receiving the Special Grace

- A. This Special Grace is established through participating in the CheonBo Holy Wine Ceremony during the 40-day period from March 26 to May 4, 2023, and through True Parents' Blessing Prayer at the 2023 Hyojeong Cosmic Blessing Festival hosted by the True Parents of Heaven, Earth and Humankind on May 7, 2023.
- B. Those who have had the problem of the fall and who wish to participate in the Cosmic Blessing Ceremony in May should consult with their church pastor and confess the content of their problem in writing in the 'Statement of Resolve to Start Anew in the Era of the Firm Establishment of Cheon Il Guk.' Then, after participating in the CheonBo Holy Wine

Ceremony and receiving True Parents' Blessing Prayer at the 2023 Hyojeong Cosmic Blessing Festival on May 7, their Blessing will be recognized.

- C. If a couple that married outside the Blessing meets the standards for this year's Special Grace, then reports this to their national headquarters Blessed Family Department, they will be established as a blessed couple.
- D. **This Special Grace is an extension of the CheonBo Holy Wine Ceremony held in 2020 and 2021.**

3. CheonBo Holy Wine Ceremony Outline

- A. Time: March 26, 2023 ~ May 4, 2023 (40 days)
- B. Venue: Churches officially registered with the regional or national headquarters (Members participating from churches located overseas can participate in the Holy Wine Ceremony hosted by regional or national headquarters through online broadcast.)
- C. Participants:
 - 1) All blessed families and members who did not participate in the CheonBo Holy Wine Ceremony in 2020 or 2021
 - 2) Unmarried matched couples, married couples, and Single Person Blessing candidates participating in the 2023 Hyojeong Cosmic Blessing Festival
 - 3) Blessed couples where only one spouse previously participated in the CheonBo Holy Wine Ceremony; such blessed couples need to participate in the CheonBo Holy Wine Ceremony together as a couple this time.
 - 4) Any blessed children that did not participate in the CheonBo Holy Wine Ceremony
- D. Holy Wine: CheonBo Holy Wine
- E. Officiator: Regional or national presidents
- F. Further details to be announced

4. Conditions of Devotion to Be Offered in Order to Participate in the Holy Wine Ceremony

- A. Period: March 26, 2023 - May 4, 2023 (40-day period)
- B. Devotions: Bowing condition and hoondokhae
- C. Resolve: All participants must sincerely repent for past mistakes and offer a 'statement of resolve to start anew in the era of the firm establishment of Cheon Il Guk' before Heaven.
- D. Donation: Each attending family is asked to offer a donation of gratitude based on the number 13.

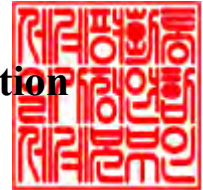

- B. True Parents’ special grace does not absolve us from the need to indemnify the violation of a nation’s laws or the harm or hurt caused to others. Such indemnity conditions must be set and fulfilled by each person.
