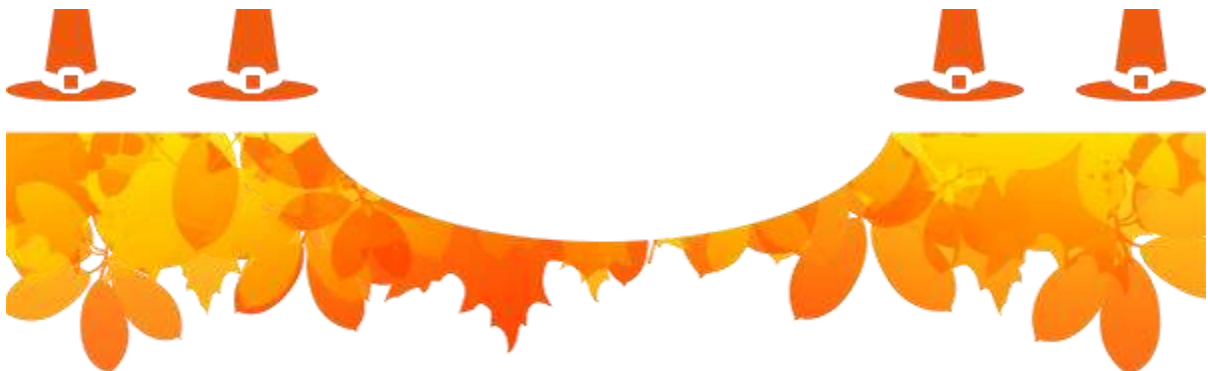

Dear IVPs, Officers and UN Representatives of WFWP International,

Warm greetings from the UN Office in New York! We are writing to inform you of CSW 59 /Beijing+20 which will take place from March 9 - 20, 2015 at the UN Headquarters in New York. The focus of CSW 59 is "The Beijing Declaration and Platform for Action."

The main focus of the session will be on the Beijing Declaration and Platform for Action, including current challenges that affect its implementation and the achievement of gender equality and the empowerment of women. The Commission will undertake a review of progress made in the implementation of the Beijing Declaration and Platform for Action, 20 years after its adoption at the Fourth World Conference on Women in 1995. The review (Beijing+20) will also include the outcomes of the 23rd special session of the General Assembly, the first five-year assessment conducted after the adoption of the Platform for Action, which highlighted further actions and initiatives. The session will also address opportunities for achieving gender equality and the empowerment of women in the post-2015 development agenda.

As is the case again this year, the WFWPI UN Office in New York may register twenty guests for CSW 59 through the official UN website. These guests will receive UN grounds passes that will provide them with access to all events. Additional guests may be registered through the NGO CSW New York Committee. These passes will allow them to attend a wide range of CSW 59 side events.

Please send us your information as soon as possible if you and your guests are interested in registering as one of the twenty guests. The deadline for submitting your request is December 10, 2014. After that time we will determine who will receive the twenty passes. This is to encourage and allow for the greatest participation from the greatest number of countries. Online registration begins this month. Please fill out the form attached to this memo. Please understand that you are responsible for your airfare, meals and accommodations while in New York City.

In addition, WFWPI will be submitting an application to sponsor an NGO Parallel event during the first week of CSW 59. A planning committee for this event is now being established. We will inform you as more information becomes available.




