May the blessings and love of Heavenly Parent and True Parents be with all mission nations.

Having successfully hosted the Events Celebrating True Parents' Centenary and 60<sup>th</sup> Holy Wedding Anniversary, and the Events Celebrating the 8<sup>th</sup> Anniversary of the Holy Ascension of Sun Myung Moon, the True Parent of Heaven, Earth and Humankind, True Mother bestowed a great providential blessing and grace to families being registered as Cheonbo families through the Grand Cheonbo Festival and the 2020 Special Blessing Ceremony. Then, on 8.25 by the Heavenly Calendar in the 8<sup>th</sup> Year of Cheon II Guk (October 11, 2020), True Mother hosted a victory celebration where she gave a precious message.

True Mother mentioned that at least one third of humankind should be restored by 2027, the year when Cheonbo families and blessed families celebrate the 60<sup>th</sup> Anniversary of Heavenly Parent's Day, centering on True Mother.

True Mother's providential message and declaration regarding the substantial establishment of Cheon II Guk through the victory of the 2<sup>nd</sup> seven-year cosmic Canaan course, her directives on the restructuring of Cheon II Guk and the reassignment of personnel have been summarized and listed below.

#### I. Restructuring of Cheon II Guk

#### 1. Purpose

- **A.** To advance the victorious establishment of a Heavenly Unified World through the 2<sup>nd</sup> 7-year cosmic Canaan course and lay the foundation for the establishment of a Heavenly Korea by 2022.
- **B.** To build a solid foundation for Cheon Eui Won, the legislative body of Cheon II Guk, ahead of the launch of Cheon Jeong Won, the central governing body of Cheon II Guk, to be located in Cheon Won Gung, due to be completed by 2023.
- **C.** To build a foundation for the third generation, the future of Cheon II Guk, centering on the grandchildren in the True Family, by fostering a foundation of unity among first, second and third generations that will create an environment conducive to national- and continental-level restoration.
- **D.** To improve the efficiency and finances of all Cheon II Guk organizations working to realize a heavenly unified world.

#### 2. Objectives

- A. Complete the firm establishment of the Heavenly Unified Korea by 2022
- B. Complete the firm establishment of the Heavenly Unified world through the substantial restoration

of one third of all regions of the world by 2027

3. Scope: Heavenly Korea and the world

#### II. Restructuring of the Global Movement

- 1. Restructuring into 9 Regional Groups (1 special regional group and 8 regional groups)
  - A. Heavenly Korea (Special Regional Group), Heavenly Japan, Heavenly North America, Heavenly Africa, Heavenly Europe, Heavenly Central America, Heavenly South America, Heavenly Asia-Pacific 1 and Heavenly Asia-Pacific 2.
  - B. Authority and responsibilities of the regional group president
    - The regional group president will serve concurrently as subregional director for the main subregion.
    - Standard for regional group restoration: Host a regional-group-level Blessing or host national level Blessings such that the aggregate population of those nations amount to one third of the population of the regional group.
  - **C.** Regional group vice-president: the regional group vice-president will concurrently hold the titles of regional YSP president and president of the 2nd generation members' association (appointments to be announced later).
  - **D.** The regional group chair designation is discontinued.
  - **E.** The transitional system of special emissaries and Cheon II Guk special envoys initiated to support the firm establishment of Cheon II Guk is discontinued.
- 2. The System of 7 Regional Groups for the Universal Peace Federation (UPF) Maintained
  - A. Each region will have a regional UPF chair and regional UPF secretary-general.
  - **B.** FFWPU subregional directors will concurrently hold the title of UPF subregional directors
  - **C.** Mr. Jacques Marion is appointed to the position of UPF regional chair for Europe. He and Dr. Katsumi Otsuka will be the UPF co-chairs for Europe.

#### 3. Implementation of the Regional Cheon Eui Won System

In anticipation of the completion of Cheon Won Gung in 2023 and the launch of Cheon Jeong Won, each regional group will implement the Cheon Eui Won system to advance the firm establishment of a foundation for future generations and the efficient restoration of the regional group by fostering cooperation between 1st generation-level leaders (elders), 2nd generation-level leaders (regional group presidents), and 3rd generation-level leaders (regional group vice-presidents). Regional Cheon Eui Won chairs are appointed accordingly.

**A.** Cheon Eui Won Chairs: In accordance with the executive bylaws of the Cheon II Guk Constitution, one of the most respected elders will be selected and appointed to the position of Cheon Eui Won chair to exercise the duties stated in the Cheon II Guk Constitution.

Role of the Cheon Eui Won Chairs: In accordance with the Cheon II Guk Constitution, the Cheon Eui Won chair has the following duties: deliberate on and adopt/reject proposed laws, budgets and projects, investigate specific issues including Cheon Jeong Won, carry out impeachment proceedings, propose and vote on constitutional amendments, review and/or initiate disciplinary proceedings against Cheon Eui Won members. The regional Cheon Eui Won chair plays the role of elder as well as that of advisor and counsel to the regional group president and regional sub-directors.

- **B.** Cheon Eui Won: The regional group president, regional group vice-president and subregional directors are concurrently members of Cheon Eui Won.
- **C.** Cheon Eui Won Executive Committee: the executive committee will consist of the chair of Cheon Eui Won, the regional group presidents, the regional group vice-presidents, the subregional directors and the UPF chairs (in special circumstances, additional members can be selected).

## 4. International Appointments: Cheon Eui Won Chairs, Regional Group Presidents, UPF Chairs

A. Heavenly Central America

**B.** Heavenly South America

#### 5. Additional Directives and Reassignment of Personnel

- A. Heavenly Japan
  - 1) An HJ Heaven and Earth Cheonbo Training Center Heavenly Japan Branch will open and the branch president will be Rev. Tokuno Eiji.
  - 2) The president (national leader) of FFWPU Heavenly Japan is Rev. Tanaka Tomihiro.
  - 3) The director of planning and coordination at FFWPU Heavenly Japan is Rev. Cho Sung-il.
- **B.** Heavenly North America
  - 1) Rev. Kim Ki-hoon will hold the concurrent roles of chair of Cheon Eui Won for Heavenly North America and chair of the promotion committee for WCLC (World Clergy Leadership Conference).

UTS is reorganized into the Graduate School of International Peace Studies and its chancellor is international UPF chair Dr. Thomas Walsh.

#### III. Heavenly Korea

- 1. FFWPU IHQ and FFWPU Heavenly Korea HQ are merged and the subregional organizations strengthened.
- 2. FFWPU IHQ, the International Headquarters Church, HJ Heaven and Earth Cheonbo Training Center are combined and will be managed as an international holy ground of faith that attends Heavenly Parent.
  - **A.** The entire HJ Heaven and Earth Cheonbo Training Center will be called Cheon Bo Won (It will also be known as the "Garden of Revival and Prosperity").
    - 1) The International Headquarters Church (Cheon Won Church) worship hall will be established in the grand hall of the HJ Heaven and Earth Cheonbo Training Center.
    - 2) Jeong Shim Won is renamed Cheon Shim Won (International Jeongseong Headquarters).
    - 3) Chinhwa Education Hall (Annex B) is renamed Cheonbo Education Center (International Cheonbo Education Headquarters).
  - **B.** The Cheonbo Education Center will specialize in raising families who have completed the Blessing of 430 couples and focus on educating and helping the spiritual development of 43 couples witnessed by victorious Cheonbo families focusing on completing the three great Blessings.
  - **C.** The president of Cheon Shim Won is Rev. Lee Gi-seong and the president of the Cheonbo Education Center is Prof. Gil Yeong-hwan.

#### 3. Status of Heavenly Korea and Restructuring

- **A.** Heavenly Korea will have the status of a special regional group and will operate under International Headquarters with five subregions.
- **B.** The subregional directors will have the position of joint regional group presidents of Korea and that of national leaders at the subregional level.
  - 1) The subregional directors will have all powers of appointment (FFWPU, UPF) and budgetary powers (tithing will be restructured centering on the subregions).
  - 2) Subregional directors will concurrently serve as subregional directors for FFWPU and UPF.

3) Subregional directors will be in charge of the central district in their subregion.

# 4. Appointments in FFWPU Heavenly Korea

- A. Rev. Lee Gi-seong: chair of Cheon Eui Won Korea, President of Cheon Shim Won
- **B.** Subregional Director for Subregion 3 of FFWPU Korea (Heavenly Nation of Chungcheong)
  - 1) Rev. Song In-young is reassigned to International Headquarters.
  - 2) Rev. Yoo Kyeong-deuk is appointed to the position of: regional group president and subregional director for subregion 3, vice president of Sun Moon University, and President of the 2nd generation association.
- C. Subregional Director for Subregion 4 of FFWPU Korea (Heavenly Nation of Jeolla)
  - 1) Rev. Lim Jong-hyuk is reassigned to International Headquarters.
  - 2) Rev. Lee Sang-jae is appointed to the position of: regional group president and subregional director for subregion 4.
- **D.** Each subregion will form an HR committee to discuss and announce personnel changes at the district and church levels and other areas.
  - 1) Pastors who have reached retirement age by February 2020 should retire. However, church pastors who completed the witnessing of 43 couples into full-time members can be appointed as Cheonbo pastors.

# 5. Universal Peace Federation (UPF) Korea

- **A.** UPF Korea will be operated as follows: UPF Korea Headquarters and five subregional branches. The FFWPU subregional directors will concurrently serve as UPF subregional directors.
- **B.** Each subregion should operate the six 'pillars' of UPF and the organizations indicated should support each association in the subregions, as follows:
  - International Summit Council for Peace (ISCP), International Association of Parliamentarians for Peace (IAPP) will be supported by the Citizens' Federation for the Reunification of the Homeland.
  - 2) Interreligious Association for Peace and Development (IAPD) will be supported by the Korea Religious Association.
  - 3) International Association for Peace and Economic Development (IAED) will be supported by the HJ Magnolia Korea Foundation.
  - 4) International Media Association for Peace (IMAP) will be supported by The Segye Times.
  - 5) International Association of Academicians for Peace (IAAP) will be supported by the Hyojeong Academic Center and the Professors' World Peace Academy.
- **C.** Reassignment of Executives
  - 1) Dr. Moon Yeon-ah will retain the post of chair, UPF Korea, but relinquishes her role as chair of the HJ World Peace Foundation
  - 2) Rev. Lee Hyun-young is promoted to the position of president, UPF Korea, but relinquishes his role as president of the Korea Religious Association

# 6. Reassignment of Personnel and Restructuring of Other Organizations

- A. Dr. Kim Hang-jae is appointed to the position of president, Korea Religious Association. He relinquishes the position of chair of the Cheon II Guk Academy of Arts and Sciences
- **B.** Rev. Sa Kwang-gi is appointed to the position of chair of the Cheon II Guk Academy of Arts and Sciences. He relinquishes the position of chair of the Cheon II Guk Academic Center
- **C.** The Sunhak Institute of History is merged with International Headquarters. Its committee chair is Rev. Yong Jin-hun and its director is Mr. Choi Chang-woo.
- **D.** Youth and Students for Peace (YSP)
  - 1) YSP international and YSP Korea will unify their operations
  - 2) Dr. Robert Kittel relinquishes his position as chair of YSP

- **E.** The HyoJeong International Training Center is newly opened to educate about the Heavenly Unified Korea. Dr. Jin Sung-bae is its director.
- **F.** Follow up announcements will be made regarding the Elder Pastors' Association, Cheon Eui Won elders and Cheon II Guk special itinerant workers

## 7. Foundations and Business Organizations

- **A.** The HJ Magnolia Global Foundation's role will be carried out by the HyoJeong Global Tongil Foundation and it will control the foundations in each region.
  - 1) International Chair: Mr. Kim Jong-gwan
  - 2) International vice chairs: Chairs of the HJ Magnolia Foundation in Korea, Japan and the US will serve concurrently as international vice chairs.
- B. Chair of the HJ Magnolia Korea Foundation: Mr. Gerard Willis
- **C.** Mr. Kim Seog-byung will serve as honorary chair of the HJ Magnolia Korea Foundation and Chair of the HJ World Peace Foundation
- 8. All providential organizations in Heavenly Korea must relocate to and operate from the HJ Cheon Won Complex. The FFWPU building in Yongsan, Seoul will be operated as a branch office of Cheon II Guk.

## IV. Administrative Matters and Other Details

- 1. All personnel reassignments are retroactively effective 8.25 by the Heavenly Calendar in the 8th Year of Cheon II Guk (October 11, 2020).
- 2. All relevant organizations must carry out proper handovers such that there are no administrative issues with personnel (leaders and members), material assets (real estate and liquid assets), and so on. Each relevant organization must send a copy of the handover report to International Headquarters.
