# 2026 Hyojeong Peace Academy Scholarship Program: Application Guidelines

**1. Purpose:** To invite outstanding talents from around the world and foster them into global leaders proficient in the Korean language

#### 2. Eligibility (All Conditions Must be Met)

- A. Applicants must be high school graduates or graduating students from overseas and eligible for admission to a Korean university.
- B. An individual who has received a recommendation from the Continental Chairman
- C. Must have a GPA of 80 or above in the most recent academic program.
- D. Korean nationals or individuals with dual nationality including Korean are ineligible
- E. Must be under 25 years old as of March 1, 2026

#### 3. Number of Recommendations

- A. Up to 5 people per continent
- B. Final selection is made through document screening and interviews

#### 10. Important Notes

- A. Scholarship will continue to be awarded if the attendance rate for the previous semester is maintained at 90% or higher
- B. Scholarship eligibility may be revoked in the following cases
- Submission of false documents
- Violation of school regulations or laws of the host country
- C. Part-time work is not allowed within 6 months after enrollment.

### **FAQ**

#### Q. What are the eligibility requirements?

The "Hyojeong Peace Academy Scholarship" aims to invite outstanding talents from around the world to nurture global talents proficient in Korean. As of March 2026, applicants must be high school graduates (or expected to graduate) from their respective countries, recommended by the continental chairperson (up to 5 candidates per continent), and have a GPA of 80 or above in their most recent academic program. Applicants who hold South Korean nationality or dual citizenship, or who have graduated from high school or university in South Korea, are not eligible to apply.

#### Q. What is the competition rate?

<sup>167</sup> Up to 5 candidates per continent can be recommended. Final selection is made through document review and interviews of the recommended candidates. The competition rate varies annually based on the number of recommendations and applications. Candidates are evaluated comprehensively on their abilities and potential. We look forward to many challenges from outstanding talents with global capabilities.

#### Q. What are the selection criteria?

The selection process consists of two stages: first, document screening; second, interviews. Based on the submitted documents including the personal statement, 2 to 3 times the number of interviewees are selected, and then final successful candidates are chosen after the interviews.

#### Q. Any tips for writing the personal statement?

The personal statement should include your introduction and background, motivation for applying, future academic plans and goals, and your vision or career plans for the next 10 years. Since the personal statement is the most important part of the document evaluation, showcase your passion and abilities with logical, well-written, and creative content, including specific examples and sincere descriptions.

#### Q. How is the scholarship awarded?

The Hyojeong Peace Academy Scholarship is awarded for one year (4 semesters) and includes tuition and other allowances. Tuition covers Korean language institute fees, and other allowances fully cover the admission fee, dormitory fees, and insurance. Dormitory residence is mandatory for the first 3 months, after that, external housing is allowed but dormitory fee support will be discontinued. Living expenses (meals, transportation, etc.) must be covered by the scholar. Violation of school regulations or host country laws may result in revocation of scholarship eligibility and deportation.

#### Q. What are the criteria for maintaining the scholarship?

The scholarship will continue to be awarded if the attendance rate for the previous semester is 90% or higher. Additionally, scholarship recipients must faithfully fulfill mandatory participation activities during their stay in Korea (such as school promotional activities and programs related to the school's founding philosophy). Moreover, the scholarship will be maintained only if the recipient does not engage in misconduct such as violating school regulations or legal issues that damage their reputation.

### Q. What happens if the submitted documents are incomplete?

If any required documents in the application form are missing or if any essential documents submitted via email are incomplete, the application may be rejected due to deficiencies. Before final submission, please carefully check that all documents are fully prepared..

#### Q. What are the obligations of scholarship recipients?

Scholarship recipients are required to diligently pursue their studies and achieve excellent results, participate in school promotional activities (such as photo shoots and interviews), engage in programs related to the school's founding philosophy, and promote solidarity and a sense of community among scholars. They must maintain the dignity expected of a scholarship recipient and avoid any inappropriate behavior or speech that could harm the school's reputation.

#### Q. Can the scholarship be revoked after selection?

Yes. Even after selection, if any submitted documents are found to contain false information, the scholarship will be immediately revoked. Furthermore, violations of school rules, laws of the host country, any behavior that damages the dignity of a scholarship recipient, or actions that harm the school's reputation may also result in cancellation of the scholarship.

## Q. Are there benefits when advancing to an undergraduate program after graduating from the Korean Language Institute?

Yes. Based on your TOPIK score, you may receive a scholarship covering 40% to 100% of your tuition for the first semester of undergraduate studies. Additionally, after admission to the undergraduate program, you can receive a scholarship ranging from 20% to 100% each semester based on your GPA.
