1. Guidelines for the Special Devotional Offering

- B. Participants: Blessed families and members worldwide\
- C. Special Devotion Offering: Guidelines by Nation Group

- 1) Heavenly Korea: KRW 130,000 or more per family (KRW 70,000 or more per unmarried adult member)
- 2) Heavenly Japan: JPY 13,000 or more per family (JPY 7,000 or more per unmarried adult member; Taiwan: Group 1)
- 3) Heavenly USA: USD 130 or more per family (USD 70 or more per unmarried adult member)
- 4) Group 1: USD 100 or more per family (USD 50 or more per unmarried adult member)
- 5) Group 2: USD 70 or more per family (USD 40 or more per unmarried adult member)
- 6) Group 3: USD 40 or more per family (USD 20 or more per unmarried adult member)
- 7) Group 4: USD 20 or more per family (USD 10 or more per unmarried adult member)
- 8) Group 5: USD 10 or more per family (USD 5 or more per unmarried adult member)

- D. Period: By September 7, 2026 (7.26 by the heavenly calendar in the 14th year of Cheon Il Guk)

2. Administrative Matters

- A. Each continental headquarters and national headquarters is requested to compile a compl

ete list of donors participating in the special devotions and submit it to the General Affairs Department of the World Mission Headquarters *prior* to remitting the funds.

The list should include: name, date the offering was received, amount offered, continent, and nation.
