At the request of UPF USA President Dr. Jenkins and UPF International President Dr. Taj Hamad, we are looking for as many letters to President Lee Jae-myung of Korea as we can get. These are letters supporting humane treatment of Dr. Hak Ja Han, our True Mother.

We're looking for a groundswell, so you may request letters from your governor, congressman, state legislator, mayor, city council member, public or private school teachers and administrators, your ministers of any religion, friends in businesses or non-profit organizations, neighborhood leaders, outstanding parents or any other of your contacts you decide on.

Attached is the letter written to the President of Korea from the Chairman of the Pakistan Senate, requested by Taj Hamad. Also attached is a similar, but slightly different, letter which your VIP contacts may use instead if they wish. OR... they may combine some elements of both letters, or (best of all) they may write their own original letter from scratch.

1. The letter should be written on the signer's own letterhead.
2. Ask for the letter to be sent to you in a Word format or as a PDF.
3. When you receive the letter, forward it immediately to Dr. Taj Hamad ([tajh@ aol.com](mailto:tajh@aol.com)). He will make sure the letter gets to the right place in Korea.

I am writing to request your intervention regarding the detention of Dr. Hak Ja Han, who is well-known in both our countries for her efforts to reduce conflict across many spheres. Most notably, she has long been a proponent of seeking ways for the Republic of Korea and the U.S. to make peace with North Korea.

At age 82, nearly blind and in failing health, with diabetes, congestive heart failure and thyroid disease. She is being kept in a detention facility in Korea without having been convicted of any crime. Her passport has been taken, and she is unable to walk unaided. It is unrealistic to call her a flight risk. The conditions of the detention center place her health and her life in jeopardy.

Dr. Moon is actively engaged with leaders and heads of state on every continent, including leaders in business, media and every religious faith. It would serve the nation of Korea well if Dr. Han, who established the prestigious Sunhak Peace Prize and has been called "The Mother of Peace," could await her trial in her home, where she can receive the medical care she needs.

I request your intervention in this matter and offer my gratitude for your consideration.


