

# **Universal Peace Federation**








# **Ambassadors for Peace**

# SUNHAK PEACE Prize Foundation

The Sunhak Peace Prize Foundation was established in 2015 to promote and develop the Sunhak Peace Prize, an annual award given to individuals or organizations that have contributed substantially to peace and human development, for the sake of future generations. The Sunhak Peace Prize Foundation has its administrative headquarters in New York. The Foundation appoints an independent, international, and interreligious Committee of judges who evaluate candidates who have been submitted by members of the Sunhak Peace Prize Nominators from around the world.

#### **CORE VALUES: A LEGACY OF PEACE**

The Sunhak Peace Prize was established to honor the lives and legacy of Rev. Dr. Sun Myung Moon and Dr. Hak Ja Han Moon, both of whom devoted their lives to peace. In 2015, the Sunhak Peace Prize was awarded to President Anote Tong of Kiribati, and to Dr. Modadugu Vijay Gupta of India. The 2017 laureates are Dr. Sakena Yacoobi of Afghanistan and Dr. Gino Strada of Italy. The peaceful world envisioned by humankind can only be built upon an all-encompassing foundation where peace among nations exists politically, militarily and religiously, and is realized by protecting family values, the sanctity of marriage, and the value of filial piety through the maturity of human character. The next Sunhak Peace Prize will be presented in 2019.
