### **CheonBo Event in Germany:**

The next CheonBo event to take place in Germany will be on the weekend of 9th – 10th November 2019.

The event will start at 12:00 o'clock on Saturday and will end at 4:30pm on Sunday. The programme will be sent out before the event.

1/11/19: Please see below for updates regarding this event, most notably the fact that those who are not physically present in Niedernhausen, or who are in the spirit world, also have to be included on the online registration form.

2/11/19: IMPORTANT UPDATE – please note that the deadline for online registration for ancestor liberation and blessing, and for bank transfer of donations is Wednesday 6th November. However, you can still register and pay cash for liberation and blessing at the desk in Niedernhausen on Saturday 9th.

Children under 6 years of age are free but need to register online as well.

This fee will cover the venue costs and a lunch on Sunday.

### **UPDATE – 1/11/19:**

The exchange rate for the conversion of dollars into euros for this event is 0.93. Please multiply your dollar amounts by the factor 0.93. For example: \$700 would be 651 Euros.

If you get decimal amounts, always round up to the full Euro. e.g. \$210 would be 195,30 € and rounded up to 196 €.

Please enter the Euros on each registration form and round them up if necessary. Special case: If someone is doing ancestor liberation and blessing, even though they are registered on the same registration form, the conversion from Dollar to Euro has to be made separately for liberation and blessing, and only then added up as a total on the top of the page.

### **Donation for Ancestor Liberation, Blessing, etc:**

Please note that the deadline for online registration for ancestor liberation and blessing, and for bank transfer of donations is Wednesday 6th November. However, you can still register and pay cash for liberation and blessing at the desk in Niedernhausen on Saturday 9th.

It is highly recommended that you transfer the donations for ancestor liberation, blessing, etc. in advance, because it is very likely that there will be long queues for registration and cash payments at the event.
