We have 6 days to gain 100,000 signatures. That means we need You (200 people minimum in the west) to get a minimum of 10 signatures a day. That should take around 1 hour. Of course many can get 100 A DAY. LET'S PULL IT OFF. Contact your friends, clergy and influential people who can get more signatures.

The Japanese government and courts approved the Dissolution Resolution. The Japanese church is attempting to appeal it. THEY NEED OUR HELP. The Japanese government will confiscate all Japanese church properties and assets unless this is stopped.

We need 100,000 signatures by March 31. Then the US White House is required to react to our petition.

Please collect signatures.

There are many ways to collect signatures (friends, Walmart, schools, street, churches, etc.). Be creative! We need at least 7,000 per day to make our goal. Here are some ideas:

1. Your phone: Have the petition website open on your smart phone and let them type in their information on your phone. An email address is required but if they don't have one, you can use "optional@gmail.com".
2. Their phone: You can print out the flyer (attached "Petition flyer.pdf") and have it on a clipboard. Let people scan the QR code from the flyer with their phone. It will take them to the petition website and they can enter their information using their own phone.
3. Paper: You can print out the Petition signature list (attached "Petition List for Japan.pdf") and have it on a clipboard. People can physically sign their name on the

paper.
Later you will need to enter each handwritten name, one at a time, into the petition website.

Many people say that college campus is a good place to go. Spanish areas may be good.

Petition to Defend Religious Freedom in Japan

President Donald J. Trump.**

We, the undersigned representatives of many faith communities, affirm that religious freedom is the foundation of all freedoms. We urge you to help Japan uphold this fundamental right and reverse its disturbing shift away from religious liberty.

The U.S. State Department's 2023 Report on International Religious Freedom stated that Japan's request to order the dissolution of the Family Federation, "marked a deviation from the norm, as previously, revocations had only been ordered following violations of criminal law." The churches and religious movements that are being attacked have not violated any criminal law.
