### 2. Special Donation:

- A. Name of Donation: Special Donation for True Father's Centenary and 60<sup>th</sup> Holy Wedding Anniversary
- B. Those who are asked to donate: All blessed families and members worldwide
- C. Special donation standard amount:
  - 1) Per family: at least US\$ 1,000
  - 2) Per individual (singles who are 18 years old and above): at least US\$ 210

- D. Special donation standard by regional group
  - 1) Heavenly Korea: at least 1,000,000 KRW (210,000 KRW or more for single adults)
  - 2) Heavenly Japan: at least 100,000 yen (at least 21,000 yen for single adults)
  - 3) Heavenly USA: at least US\$ 1,000 (at least US\$ 210 for single adults)
  - 4) Heavenly Europe: at least US\$ 1,000 (at least US\$ 210 for single adults)
  - 5) Heavenly Asia-Pacific: at least US\$ 200 (at least US\$ 40 for single adults)
  - 6) Heavenly Africa: at least US\$ 100 (at least US\$ 21 for single adults)
  - 7) Heavenly Latin America: at least US\$ 150 (at least US\$ 30 for single adults)
- E. Deadline for making the donation: 12.6 by the heavenly calendar (Dec. 31, 2019)
- F. Special donation goals for each regional group and providential organization will be announced later through a separate memo.
