#### I. GUIDELINES

# Based on the Notes Taken During the Leaders' Meeting from Rev. Yong:

- A. The mission of Philippine brothers in Japan to live with their families while doing the following missions as Philippine Church members.
  - 1. Witnessing mission
  - 2. Establish Philippine church centers in Japan.
  - 3. Financial mission includes the goal of constructing the Philippine Cheon Bok Gung in Tanay.
- B. Japanese wives will focus on the education of the second generation.
- C. Japan-based Philippine members will be divided into 3 regions
  - Region 1 Northern Region (Tokyo)
  - Region 2 Central Region (Mie-Ken, Nagoya, Osaka)
  - Region 3 Southern Region (includes Okayama, Kyushu-Okinawa)
- D. Each Region will have (1) Regional Leader and (2) Vice-Leaders. Philippine sisters can only become Vice-Regional Leaders.
- E. The Executive Director will be elected or appointed from among the (3) Regional Leaders. Regional leaders who are not elected or appointed as Executive Directors, automatically become Vice-Executive Directors.
- F. Each region should create a committee to plan, strategize and implement church activities in their respective regions.
- G. Philippine sisters blessed to Japanese members should be able to join us as Filipinos in doing all these activities.
- H. Use your innovation and creativity to develop a good organization with a clear and workable vision-mission statement, goals and activities in order to succeed.

#### II. Vision, Mission and Goals

## A. Vision: A Church in Every Home, A Center in Every Community

#### B. Mission:

- 1. Strengthen the blessed families as the practitioners and examples of Divine Principle education and traditions of true love, true life and true lineage taught by the Rev. Sun Myung Moon.
- 2. Extend the home as a family church especially on Sundays to witness to True Parents as the Messiah through our lifestyle as blessed central families.
- 3. Create centers of religious fellowships and educational activities in communities where we live.
- 4. Institutionalize the fulfillment of our overall mission as a church in Japan.
- 5. Boldly proclaim the Church and witness to True Parents to tribes in the Philippines and Japan.
- 6. Undertake model witnessing and peace activities to help pave the way for the eventual entry of True Father in Japan.
- 7. Create activities that will promote ideal families and healthy lifestyles by educating blessed couples and blessed children using a standard program for teaching the Divine Principle, the traditions and speeches of True Parents.
- 8. Utilize immediate changes and specific aspects of life in Japan as a tool for the innovation of strategic programs and activities.

#### C. Goals

1. Implement a Blessed Neighborhood Program where blessed families and invited guests can gather in a blessed family's home on a rotation basis in order to undertake Hoon Dok Hae sessions at least once a

month.

- 2. Activate non-donating and less-participative couples and families by engaging them in a variety of ways including non-formal and less-structured approaches.
- 3. Establish (buy or rent) at least one center in communities where blessed families live.
- 5. Own and operate facilities (TIMD dojangs, nursery schools, mini-libraries or reading centers with DP schedules, etc) for the fulfillment of our overall mission as a church in Japan.
- 6. Each member should witness, continuously educate, and make blessing candidates at least, one person per month. Each should follow up their contacts t¥until they are able to start their blessed families.
- 7. Use our social and virtual (cyberspace) connections to promote Unificationism and create blessed families and communities.
- 8. Inspire our Japanese brothers and sisters to witness publicly to True Parents by setting an ideal model for fulfilling our witnessing mission.
- 9. Create and implement financial activities that aim to support the construction and development of Chun Bok Gung in Tanay, Philippines.
- 10. Establish practical and workable solutions to support tribal messiah activities in coordination with local leaders and members.
- 11. Sponsor and assign Philippine missionaries in Japanese communities where most UC-families live.
- 12. Conduct regular or occasional activities that go hand in hand with Japanese cultural and traditional activities in order to eliminate inappropriate perceptions about our movement in Japan.

## III. Programs of Organization

To achieve the mission of the organization, the following programs shall be implemented:

#### D. 2nd Generation Education Program

- 1. Outdoor Education

- 3. Young Computer Whiz and Design Programmers

## E. Financial Activities Program

- 1. Monthly Contributions to Blessed Families Support and Emergency Fund. Support fund in case of sickness, death, burial, etc.
- 2. Investments in Small and Medium-Based Business Enterprises.
- 3. Create, engage or get involve in business clubs to gain ideas and establish our own.

## F. Program for VIP/IPLC Development

- 1. Coordinate with Philippine Church Hqs about financial and improvement needs.
- 2. Effective planning with regional leaders, implementation of

donation system and regular development reports.

## G. Tribal Messiah Program

- 1. Use of model tribal activities from overseas members.
- 2. Individual and Group Activities
- 3. Monthly Reports
- H. Cyberspace Ministries and Programs
  - -Bloggers, Reporters and Writers Pool
  - -Coordinated Responders of Local and National Concerns

## **B. Strategic Activities**

- Make circles or groups for each sector of Japanese society and use it to achieve our goal of teaching Divine Principle and make ideal blessed families.
- Study and use Japan's cultural and social environment to our advantage.
- Education through service and fellowship.
- Maximize the utilization of free space and free time.
- Use organizations and social networks to promote Unificationism in a variety of ways like offering positive, meaningful, and life-giving sports and entertainment.


## IV. UCPJ Organization

## A. Organizational Composition

1. Unification Church members living in Japan are members of the Philippine Unification Church. Henceforth, we are called Japan - Philippine Unification Church Ministry.

- 2. Japan-based Philippine church members are under over-all structure and supervision of Philippine Unification Church.
- 3. Japan-based Philippine members will be divided into 3 regions
  - Region 1 Northern Region (Tokyo to Hokkaido)
  - Region 2 Central Region (Mie-Ken, Nagoya, Osaka)
  - Region 3 Southern Region (includes Okayama, Kyushu-Okinawa)
- 4. Each Region will have (1) Regional Leader and (2) Vice-Leaders.
- 5. The Executive National Minister will be elected from among the (3) Regional Ministers. Regional Ministers who are not elected or appointed as National Executive Minister will automatically become National Vice-Executive Ministers.
- 6. A National Council of Elders may be set-up to consult or advice the Executive Director in the promulgation and implementation of policies and activities of the church that need extra support and attention. It will be composed of former national ministers, 3 Regional Ministers, 3 sub-leaders (1 from each region). Note: The concept of Council of Elders was part of our proposal to Mr. Jun Basuil, National Leader of the Philippine UM.
- 7. A Regional Council of Elders may be set up to consult or advice the Regional Minister in the promulgation and implementation of policies and activities of the regional church. It will be composed of former Regional Leaders, the (2) Vice-Regional Ministers, center ministers or (2) representatives.
- 8. Each minister may have their own special staff or volunteers to assist them in the performance of their respective functions or responsibilities.

## **B. Structural Organization**

## C. Functions and Responsibilities

**The Executive Minister -** The Executive Minister is responsible for:

• The implementation and supervision of continental and national directions.

- Coordinates and helps in the settlement of national and regional issues, policies and situations.
- Facilitate communication between ministers and members, between the movement and other organizations necessary for the movement's implementation of projects and linkages
- Update the UM Philippine national leader and the general membership about developments and issues concerning the extent of our providential work.
- Make a report every six-months or twice a year in order to update members of present situation, goals and activities.
- May recommend to the NCE, the expulsion or removal of a ministry officer.

(Refer to the NCE's recommendatory provisions).

## The Regional Executive Minister -

The Regional Minister is responsible for:

- The implementation and supervision of directions in the regional level.
- Coordinates and helps in the settlement of regional problems.
- Make a six-month report or twice a year to update members of present situation, goals and activities.
- May recommend to the NCE, the expulsion or removal of an officer. (Refer to the RCE's recommendatory provisions)

**Vice-Regional Minister (VRM)**– The Vice-Regional Minister may take any responsibilities that the Regional Leader (RL) may assign to him. He is the alter-ego of the RL when the RL requires it. He takes the place of the RL in the event of sickness or in any case of inability or disability to manage regional issues, policies and activities.

#### **Center Minister –** The Center Minister is responsible for the:

- Planning, reporting and implementation of local plans and activities.
- Education of guests and training of new members about the Divine Principle and the ten (10) traditions of True Parents.
- Local assessment and coordination of activities to the Regional

#### Leaders.

#### **National Council of Elders**

The National Council of Elders (NCE) will be composed of all former National Ministers of FilJap, 3 Regional Ministers and one (1) representative from the sisters group.

The function of the NCE is purely advisory, consultative and recommendatory. They may not interfere in the daily management and operations of the church.

#### Recommendatory Provisions

Any member of the NCE may make a motion to recommend for the reprimand, suspension, expulsion or replacement of the Executive Minister or any of its members due to:

- 1. Incompetence
- 2. Acts of immorality or lasciviousness
- 3. Financial corruption
- 4. Inability to explain immorality or corruption issue and,
- 5. Unprincipled acts that are considered inimical and sacrilegious to the majority of the NCE.

### **Regional Council of Elders**

The Regional Council of Elders (RCE) will be composed of all former Regional Ministers of FilJap, the Vice Ministers and (2) two members representing the brothers group and the sisters group.

The function of the RCE is purely advisory, consultative and recommendatory. They may participate in any planning and activity of the region but they may not interfere in the daily management and operations of the regional church, organization or facility except upon expressed or written approval of the RL..

#### Recommendatory Provisions

Any member of the RCE may make a motion to recommend for the reprimand, suspension, expulsion or replacement of the Regional Minister or any of its members due to:

- 1. Incompetence
- 2. Acts of immorality or lasciviousness
- 3. Financial corruption

- 4. Inability to explain immorality or corruption issue and,
- 5. Unprincipled acts that are considered inimical and sacrilegious to the majority of the RCE.


