

On the eve of the trial, which is scheduled to begin on the morning of December 1, a noteworthy editorial appeared under the title "종교지도자 재판, 불구속이 바람직하다" ("In Trials of Religious Leaders, Non-Detention Is Preferable"), published by Asia Today and carried on the Nate News portal.

The editorial points out something the world already understands intuitively: when a state chooses to detain a religious leader, the signal extends far beyond the legal process. A leader represents an entire faith community, and confinement naturally creates the impression that the religion itself is being suppressed. The piece also highlights the humanitarian reality. Dr. Han is eighty-two and managing serious health issues.

"Keeping her in detention presents clear and unnecessary risks, and the editorial states plainly that if harm comes to her, responsibility rests with the Korean government."

It also touches on the situation of Pastor Son in Busan, whose arrest over alleged election-related speech has unsettled Christian leaders nationwide. When sermons can be criminalized, every religious community feels the pressure.

Asia Today's editorial reflects a growing unease inside Korea as this case reaches a critical moment. I encourage you to read the full text below.

In Trials of Religious Leaders, Non-Detention Is Preferable [Editorial]

More than fifty world religious leaders held a press conference on the afternoon of the 13th in front of the King Sejong statue at Gwanghwamun, expressing support for religious values, religious conscience, and calling for the release of President Hak Ja Han. /Reporter Park Seong-il

For ordinary citizens, and especially for religious leaders, it is the principle and the desirable practice that both investigations and trials proceed without detention. A religious leader represents a particular religious community, and therefore detaining such a figure can easily be regarded as suppressing the religion under their leadership. If prosecutors or the judiciary carry out excessive search-and-seizure operations or detain a religious leader, controversy over "violations of religious freedom in Korea" is bound to arise both domestically and internationally.

In fact, on August 25, ahead of his Korea-U.S. summit with President Lee Jae-myung, U.S. President Donald Trump remarked that he had heard that "very vicious raids on churches" were taking place in Korea. After Trump's comment, political figures in the United States also raised their voices warning of violations of religious freedom in Korea. Investigations or detentions involving religious institutions or religious figures are issues that provoke extremely sensitive reactions both inside and outside the country. Therefore, requests for and approvals of detention warrants for religious figures must be handled with great caution.

Unfortunately, this has not been the case in reality. The Busan Metropolitan Police Agency, while investigating Pastor Son Hyun-bo of Busan Segero Church on charges of violating the Public Official Election Act, sought an arrest warrant citing concerns of "flight" and "destruction of evidence." However, this triggered strong backlash, with critics arguing that "If even a pastor's sermon is restricted, the essence of religious freedom and freedom of expression is harmed. A pastor has no reason to flee, and his statements are already preserved on video, so there is no possibility of destroying evidence. Therefore, detention is excessive punishment and an act of religious oppression."

On December 1, the 27th Criminal Division of the Seoul Central District Court will open the formal trial of Unification Church President Hak Ja Han. On the same day, a hearing will also be held regarding President Han's request for bail, which would permit release under conditions such as a security deposit. While the trial itself must of course proceed in a strict and proper manner, whether there is any need for it to proceed under detention is a separate matter. When the bail hearing is held, we hope the court will take into consideration the fact that she is a religious leader and avoid unnecessarily provoking domestic and international controversy over "religious oppression."

Furthermore, President Han is elderly and is reportedly suffering from heart disease and various other illnesses. If bail is not granted and she undergoes trial while detained, and if her health worsens or an unforeseen incident occurs, the government must remember that it would bear full responsibility.

President Lee is known to have overcome countless difficulties and trials since his youth. Precisely because he has personally experienced suffering more than anyone, President Lee needs to make a decision, for the sake of national unity, to show leniency toward the elderly President Hak Ja Han, who is battling illness. If President Han's trial proceeds not under detention but under bail, it will not only dispel misunderstandings that religious freedom is being violated, but will also carry great significance for national unity.
