The Unjust Detention of Dr. Hak Ja Han — A Case Built on Hearsay and Contradiction

The recent detention of Unification Church Dr. Hak Ja Han, known as the Mother of Peace, has sparked significant controversy, not merely due to the high profile of the figures involved, but because of the fragile evidentiary foundation upon which the investigation rests.

A forensic analysis of recent developments reveals that the allegations of political lobbying are driven almost exclusively by the testimony of one individual: former World Headquarters Director Yoon Young-ho.

When scrutinized against objective timelines, independent political commentary, and internal records, Yoon's testimony collapses, revealing a case built on uncorroborated hearsay and self-serving fabrication.

I. The Legal Vacuum: Hearsay Disguised as Evidence

The core of the prosecution's case relies on Yoon Young-ho's assertions that he delivered funds under instruction. However, legal experts and veteran politicians have pointed out the **glaring lack of physical evidence** to support these claims.

Representative Park Jie-won, a prominent opposition figure, publicly defended one of the accused recipients, Rep. Jeon Jae-su, stating,

"There is no physical evidence like the two watches... no concrete events have emerged."

He further critiqued the investigation's reliance on Yoon, noting that

"statements coming out from former Director Yoon waging his glib tongue are only that 'I heard someone gave it'," emphasizing that such "hearsay evidence is not recognized even in court"

This legal fragility is compounded by the police's own admission of difficulty. Reports indicate that despite search and seizures, the authorities are struggling to prove the core element of bribery—"quid pro quo"—and are relying on statements that lack specifics regarding time, amount, or delivery method (Doubts Over Credibility of Yoon Young-ho's Statement..., Mindle News, 2025).

II. Factual Impossibilities: The Alibi that Breaks the Timeline

The credibility of Yoon's testimony is further eroded by demonstrable factual errors. Yoon claimed that Rep. Jeon Jae-su attended a Unification Church event at the Busan BEXCO on May 27, 2018. However, objective evidence contradicts this entirely.

Photographic records confirm that at the exact time of the Unification Church event, Rep. Jeon was attending a 60th-anniversary mass at Gupo Catholic Church, approximately 15km away. The clock in the photograph points to 12:13 PM, providing an ironclad alibi that renders Yoon's account physically impossible (Doubts Over Credibility of Yoon Young-ho's Statement..., Mindle News, 2025).

If the primary witness constructs a narrative that is spatially and temporally impossible regarding one target, the reliability of his entire testimony regarding President Han's involvement is fundamentally compromised.

III. The "Smoking Gun" of Rogue Behavior

Perhaps the most damning evidence against the theory of President Han's "instruction" comes from Yoon Young-ho himself. A recently released transcript from April 2022 captures Yoon admitting to a private meeting with then-President-elect Yoon Suk-yeol.

In his own words, Yoon stated,

"I couldn't even report to Mother [President Han] that I was going to do this," and later noted that President Han was "surprised" when she found out. He further admitted, "I should probably report on inter-country projects *after* I have created and executed them"

(Yoon Young-ho "Met with Yoon Alone Without Reporting...", News1, 2025).

This admission aligns perfectly with Dr. Han's statements to police, where she denied knowledge of the bribery and attributed the issues to incidents that "occurred as Yoon Young-ho... wielded significant authority" ([Exclusive] Han Hak-ja "Unaware of Bribery Suspicions...", MBN, 2025).

It corroborates the testimony of former Vice President Lee, who characterized Yoon's actions as a "water ghost tactic"—a strategy to drag others down to dilute his own responsibility—and noted that Yoon used the President's trust to pursue his own political desires outside the church ([Exclusive] "If Yoon Young-ho Hadn't Prepared It...", Kukmin Ilbo, 2025).

Conclusion

The testimony of Dr. Han, the primary witness in this case, is fundamentally compromised.

The detention of Dr. Hak Ja Han appears to be a miscarriage of justice driven by the "water ghost" tactics of a former executive seeking to evade sole responsibility for his unauthorized actions.

With objective alibis disproving Yoon's timeline, prominent politicians dismissing his claims as inadmissible hearsay, and his own voice recordings proving he acted without Dr. Han's knowledge, the narrative of "instruction" falls apart. The investigation must pivot to the objective facts, which increasingly exonerate Dr. Han.
