Old Business:

A. National Council

- Mr. Alain Tamelessio gave a report on the Nation Council Meeting. It was stated that 56 grant proposals were submitted not including late submissions. The Clifton Council Grant was received 15 minutes late by despite email submission being prior to midnight. Due to this fact, officially the Clifton Council Grant is not accepted. It was also mentioned that National Council is developing specific policies for handling a wide range of issues ranging from personal to legal. Likewise, the specific methods for how grant funds are decided by the 12 National Council Members is one of those policies. (See Mr. Tamelessio for more details.)

B. Camp Sunrise

- The board for Camp Sunrise does not have adequate representation for NJ Church Community. Because Camp Sunrise has a financial report meeting occurring within the next two weeks, council decided to elect new representatives to sit on the board. To prevent legal issue and to ensure adequate representation on the financial decisions of Camp Sunrise, Meadow was put on the board to represent NJ; a second represented is to be announced. The camp itself was discussed and will be discussed at the next council meeting that follows the Camp Sunrise Board meeting.
