

Urgent Report on the May 30 Incident in Brazil

I am sorry that I am in a position where I must report on the Brazil incident. We hear from far-off Asia that True Parents have forbidden Hyun Jin Nim from engaging in public activities, forbidden the use of the term GPF and bestowed the precious name GPHA to take the place of GPF. Therefore, when we continue to receive news updates related to GPF, which is being run by Hyun Jin Nim, it creates great confusion in the Unification Family. Now this has suddenly come to Latin America. We have witnessed a church podium being taken over during a pastor's sermon.

What happened in Brazil was truly enormous. The headquarters church sanctuary in Brazil is in True Parents' official residence (God's Formation-stage palace), where we are expected to practice True Parents' teachings about true love and offer reports to God, in order to develop a deep inner heartistic connection with God. On May 30, members were determining and pledging to live peacefully, as True Parents have shown us, while commemorating the publication of *As a Peace-Loving Global Citizen* in Portugese.

True Children should be the greatest examples of upholding True Parents' authority and of following True Parents' orders and policies. However, a True Child and his followers came to the headquarters church sanctuary on this day, bringing rampart rupture, defiance, conflict, hate and violence instead of peace and harmony. This was even exposed by Internet live broadcast, throwing the worldwide Unification Family into shock and confusion. Hence, I cannot but feel deeply guilty and sorry before Heaven.

In contrast with methods employed in Asia, now that Hyun Jin Nim has passed his 41st birthday (which was on May 23), they are saying that they are determined to no longer be silent – that they will say what they feel must be said. They made elaborate preparations, even to force their way into the church building and confiscate everything. They are publicly declaring a war or a revolution against the so-called corrupt and false Korean leaders and national leaders who listen to such leaders. Saying that they are opening a new day for the Providence in Brazil, they are acting as though they are revolutionary fighters who will liberate the Brazilian church from tyranny. I could not bear to look at what they were doing.

I realized through what Mr. Jin Man Kwak said to me when he came to the continental headquarters (after everything was over and things had quieted down), that there had been intent from beforehand to use violence, instead of trying to resolve the issues in other ways.

I only figured out later that they assumed there would be no problem holding an event if they used members' longing for True Children to mobilize members to come. Only they knew the purpose of the event. They were sure that their plan would work and the event could be held without compromise.

Having spread word that the memo from the World Headquarters forbidding events was false, they assumed that Hyun Jin Nim's gathering at the headquarters church would take place as they expected.

I found out that they employed various methods to mobilize members, such as providing a bus for members and missionaries who lived more than ten hours away (who would normally take a plane). Members in many locations had already strongly refused to attend. However, in churches near Sao Paulo, there was a lot of curiosity due to the controversy before the event, possibilities of confusion due to the differences in two totally opposite points of view, and members longed to see a True Child, so many members attended the event. Of course, as a result the members who attended received two or three times the amount of shock.

I explained over and over again that it goes beyond all reason for anyone (even a True Child) other than a gangster (who may be willing to take any risk) to violently intervene in a place which has True Parents' picture and chairs – a place in which we should have the same standard of heartistic attendance as if True Parents were there in person. That is because it is an altar where God's words are being conveyed. We don't think of that altar as a simple stage of a lecture hall. Though True Parents could not be there in person, with True Parents' picture and chairs, we hold a service with the same heart as though the True Parents of Heaven, Earth and Humanity (God in visible form) were there in person.

We believe that God and True Parents are there spiritually. This is not only commonsensical for church leaders, but it is also basic decorum and propriety for people of faith. If this type of holy legacy of our True Parents is to be broken, especially by one of the True Children (for whom we have the greatest respect and whom we always long to be with) then resentment, cursing, criticism, conflict and division will ensue. If a True Child makes comments that shake the foundation of our public organizations, then how could he be seen as having the heart of attendance toward True Parents? I absolutely do not see such behavior as reasonable.

But what actually took place destroyed the one stitch of hope I had.

Though I was told that there was a hotel room prepared to attend Hyun Jin Nim in case the determination of the continental director to not allow Hyun Jin Nim to speak at the pulpit was absolute, after he arrived at the airport, Hyun Jin Nim came directly to the Sao Paulo church.

Of course, Hyun Jin Nim, who arrived while the worship service was taking place, did not go directly into the room where the service was taking place. He first went to the waiting room which had been prepared on the fifth floor (Rev. Heung Tae Kim's room and office), then went to the Small Sanctuary on the 5th floor since the service was taking place in the main sanctuary. It seemed that Hyun Jin Nim had started speaking on the fifth floor since there were people gesturing for people to leave the main sanctuary

during the service. I am not sure why, but not many members left. The large majority of members quietly remained in the sanctuary, listening to the sermon with a prayerful heart. I later found out that around 90 young people from all over Latin America (who were under Missionary In Don Kang's leadership) and an extremely small number of members listened to Hyun Jin Nim. He may have thought that more members would come after 5 or 10 minutes had passed, but when the number of members remained the same, Hyun Jin Nim suddenly ended his speech in the Small Sanctuary after having spoken for around 15 minutes. He then returned to the room that had been prepared for him. I thought that might be the end. I thought that he might be quietly reflecting on his current situation, in which he cannot receive a formal welcome.

I assume that Missionary In Don Kang and others conveyed my consistent claims and my strong will to attend Hyun Jin Nim as well as possible but to never allow what must not be allowed. So I thought he would conditionally speak to the people who greeted him in the Small Sanctuary, end, and eat on the fifth floor where lunch had been prepared for him. He could have naturally received flowers, eaten and had a meeting with the major leaders in Brazil. I thought that would be the reasonable thing for him to do. That is, unless he had some clear plan and goal to take over the Brazilian church even at the risk of his life.

They explain that there had been an agreement with the continental director that Hyun Jin Nim would speak after Sunday service, or that flowers would be given to Hyun Jin Nim upon arrival, and then there would be a short time for him to speak with the continental director before lunch and a leaders' meeting. However, neither of these claims is true. From the beginning, I consistently said, "Hyun Jin Nim may not speak at the Sunday pulpit. I will prepare anything else with my devotion. The only reason for this is that True Parents have not given their permission." Therefore, after quickly finishing the Paraguay tour and returning to Sao Paulo on the evening of the 28th, I went to inspect the room that was being prepared for Hyun Jin Nim and gave words of encouragement to the members who were working hard to prepare the room.

The international memo is one of the pieces of evidence. Some people ask why the memo does not have Hyung Jin Nim's name on it. However, there have been many memos, such as memos for general communications or for passing on directions, which come without Hyung Jin Nim's name. The recent Day of All True Things event memo didn't have Hyung Jin Nim's name on it. There are some international memos signed by the vice president of the World Mission Headquarters. However, not once in my time as a church leader have I denied or questioned a memo because of the signature on it. If anyone is suspicious, all he needs to do is to call the phone number listed on the letterhead. In Korea, nowadays urgent work-related communications are sometimes sent out by text message.

This story is getting long.

Preparations to take over the worship hall by force were quickly completed. All the young adults who were mobilized from the outside, who were like Hyun Jin Nim's soldiers and not followers of True Parents, were gathered. They physically raided the sanctuary, dragged Rev. Shin (who was sermonizing congratulations on the occasion of the publication of True Father's autobiography in Portuguese) off the stage and gave Hyun Jin Nim the podium. It seems that Hyun Jin Nim's senior staff had determined to do this.

Also, tens of people came on stage at the same time and took the microphone away in the middle of the sermon. No opportunity for explanation was given, while expert martial artists and bodyguards dragged me out of the sanctuary by force.

The next day, in contrast with the original plan, Hyun Jin Nim came to Hoon Dok Hwe and said that he would fire church president Simao and church vice president Carlos (who followed directions given by the international headquarters and the continental director instead of decisions made by [Brazilian HSA-UWC] board members who were centered on UCI) even though he had no public responsibilities, let alone any qualification or authority to do so. Moreover, he said he would appoint new staff. He announced that he would appoint Juliano to be the new church president. He called the continental director, who had been physically pushed out of the Hoon Dok hall, back into the hall and made a personal attack against him, scolded him in a loud voice, saying that these stupid Korean leaders messed up Brazil.

By the way, it is customary for the continental director to be directly appointed by True Parents. Though Hyun Jin Nim is a True Child, he does not know his own identity and has invaded True Parents' special authority, acting as though he is True Parents himself. That is wrong. Some people cannot believe it, but this was a clear scene which made me seriously worry whether Hyun Jin Nim and his group think that Father is now too old to have dominion over the Providence directly.

The people who did not understand the Principled rules and the beautiful tradition of our True Parents did not seem to even feel any guilt even as they put forth Hyun Jin Nim’s rank as a True Child to fulfill their own purposes while completely ignoring the traditions and legacy of our True Parents and carrying out terrible deeds that would anger both God and humanity. Unimaginable things happened here, such as the members singing “Hurray!” in such a situation. And they are taking these false words that throw contempt on True Parents’ power and authority, these shocking statements by Hyun Jin Nim, and spreading them unfiltered here and there. These people, who say they are out to help the True Family, are in reality disgracing the names of True Parents and True Family. In any case, as a leader in a position of responsibility, I am seriously reflecting on my inability to guide members better so that such terrible things may have never happened in Brazil.

I clenched my teeth in determination to protect this True Child in front of the members who had gathered, so I could do nothing but be hit while shedding tears. But when he bullied me, asking whether I really heard that GPF should not be done, I had no choice but to convey True Parents’ direction. Yes. Father clearly said to not even use the word (GPF). While I conveyed this, I tried to follow the standard and direction of True Parents and the International Headquarters. A long time ago, True Father told us in Alaska that no one other than True Father can stand in the center or the position of the owner. This is known as the “Kodiak spirit.”

Later, after we moved to the 5th floor cafeteria, Hyun Jin Nim gathered key leaders and asked them something that might be expected of a revolutionary force that just succeeded at carrying out a coup d’état: “Will you follow the continental director, or will you follow Hyun Jin Nim?” (It is hard to believe, but that is the kind of atmosphere that was present in Sao Paulo at the time.)

Hyun Jin Nim demanded of people one by one, almost coercively, to promise and pledge to follow him. Unless someone has nerves of steel, it is very difficult to say no in that kind of atmosphere. In fact, scientific experiments have shown how weak our convictions are. If most people say that we are wrong, and we hear that repeatedly, our own convictions can easily change. We may even change our conviction about something as simple as the length of a stick, which a three-year-old child could clearly distinguish, with a few experiences that contradict our convictions. Psychologists are not shocked by such things.

On June 1, Hyun Jin Nim left for Paraguay. However, two of his key supporters (members of the board) have remained and have threatened to sue if the president and vice president do not willingly resign. They are applying pressure, saying that they will close down the church. Their continuous threats and intimidation are like that of the Mafia or gangs that we see in the world. We are hearing more and more rumors about organizations making secret agreements to go over to the UCI side after talking with these board members. I and Rev. Heung Tae Kim basically respect and are moved by the letter Myung Soon Kim (wife of board member Mauricio) sent to Hyun Jin Nim. Though we believe [that the letter was sincere], when I consider the possibility that there may be a truly enormous plot behind the letter I feel goose bumps all over my body.

Due to the unprecedented events that took place during the past two days, there is enormous shock in Brazil, and the pure hearts of tears with which members came have now become mixed with shock and frustration. No matter how much Hyun Jin Nim wanted to come to Brazil, before buying his ticket to Brazil, he should have bought a ticket to Korea so he could attend the Day of All True Things event and meet with True Parents, who miss him so much.

In Don Kang {older brother of Soon Ok Kang, who is the wife of Jin Hyo Kwak (second son of Rev. Chung Hwan Kwak)} was preparing for these things in secret and was the mastermind of what happened. Even though Hyun Jin Nim had been appointed as president of World CARP, In Don Kang secretly retained young members. I allowed him to visit the field (members/mission countries) together with me [trusting him] but this time he prepared this visit as if he were part of a death band¹ for Hyun Jin Nim. He even lied to the World Mission Headquarters, saying that he would absolutely unite with the continental director, while he prepared for these events in secret. Up until it was time for the event to begin, in his emails he said that he would not and could not actively participate in the events. However, he was actually playing the core role of a vanguard, connecting the team coming from the outside to the field.


Of course, the national leader in the field and I had no idea about this. After the Ascension Festival in

Mexico, my next tour schedule was in Paraguay, but I stopped for a short time at the Brazilian airport on the 26th on my way to Paraguay. In the airport, I heard the news and gave a strong direction to the national leader that we must follow the directions of the international headquarters, and that we would make a final decision when I got back. And we made an appointment to meet at 10am on Saturday about the event.

In Paraguay, I visited the field together with the family of Lawyer Maria, whom Rev. Pyeong Rae Moon had introduced to me, the lawyer of the Mission Foundation, and Rev. Sang Pil Moon. I dealt with various issues, for example the mandatory report requested by the Korea Forest Service of Victoria, a company which is currently managed by Hyun Jin Nim in practice. I finished my business in Paraguay ahead of schedule, getting back to Brazil on Friday evening.


I sent the memo from the international headquarters to the field, conveying the will of the international headquarters. But I found out that they called each church, offering to provide bus transportation [for the members] to go and see a True Child. This is actually a very beautiful thing, right? In an ordinary situation, this would be the most correct attitude. The members in the field had seen Hyun Jin Nim in the past (in 2008 for example), so they were interested to hear him speak despite the memo. I think many people must have been overjoyed to hear that there will be no problems with the event and that they should come without any worries. The picture on the official Skype account for the Latin American headquarters had been changed to Hyun Jin Nim's picture and the date for Hyun Jin Nim's Sunday visit was included next to his picture. The official Skype account is mainly managed by Mr. In Don Kang and Chiago, a member of the continental headquarters staff who stays at Mr. In Don Kang's CARP center (also called the Il Guk Center). The email is being handled thoroughly by the account manager but the Skype account has been handled by many staff members over the years so (I am told that) many people know the password. But these were all staff brought in by Mr. In Don Kang. Of course Mr. In Don Kang knows, but it was urgent so I called Chiago and Mr. In Don Kang in the middle of the night and told them to quickly change [the picture and message on the Skype account]. Of course, we can no longer log in using the password that had been used up until now. I have no idea how on earth such a thing could be done in the name of the continental headquarters.

The story continues but these kinds of things happened as well. Of course, I immediately captured screenshots with my computer and saved these things as picture files. I even had to make an email address in my name. The picture below is an automatic email sent by the Skype main office to our HQ email informing that information had been changed.

These kinds of unimaginable things are still happening now. The beautiful tradition, legacy and customs of our faith, the existence of the spirit world, True Family and such things all flew out the window in those moments.



Are they perhaps trying to make us into criminals so that we will be on their side?

Even in this type of situation, I did my best. I did not immediately fire Mr. In Don Kang. I wanted to get rid of my emotions and engage in a conversation with him. And I wanted to understand his physical feelings and his attachment to Hyun Jin Nim. I respect his attitude toward True Family.

I waited for 10am on Saturday to arrive. I did not call the field and encourage them to come to the event or to not come to the event. I acted as though it was a regular visit when I would give a Sunday sermon. It was getting very late [on Saturday night].. 2am, 3am, but there was no contact. I expected them to come by 9am so we could talk before Sunday service. I was being very firm so I thought that maybe they decided that Hyun Jin Nim would go to a nearby hotel since they said they prepared a separate hotel room for Hyun Jin Nim. I had a lot of thoughts in my head but in the end I went into the sanctuary early, at 8am, and read my sermon notes over and waited while praying silently. I waited and waited. But no one came and we started service as normal.

We know well the tradition of the Unification Family. Despite the circumstances, I had to hold the service and I could not call the police. Neither could I block with my body. My determination was to use my will to keep my feet on the stage. And I would need to control my rage so that I don't do something [I would regret]. In the end, no one came so I had to start the service without speaking or meeting with [any representative of Hyun Jin Nim].

I determined that I would keep to my principles. But they were already determined. I only found out later that they had truly prepared meticulously, even planning ahead as to what they would do after kicking out the national leader who did not listen to them and who remained united with the continental director.

It seemed like they wanted to misuse the fact that I had no choice but to follow the directions of the international headquarters, and they wanted to make an issue out of the situation. I was so enraged and full of heat. Yesterday evening the Mauricio couple and Clovis came and repeatedly said that there would just be a flower presentation and a chance for Hyun Jin Nim to greet with the mic. I asked if they would sign a document promising that they would take responsibility for that. At first, they said that Hyun Jin Nim would speak for 5 minutes, then they said 10 minutes, then 15 minutes, and finally they said that they cannot take responsibility because they could not limit the time for a True Child to speak. They said that they were just there to let me know about this decision and then left.

Now they lie, saying that I made a firm promise as the continental director but did not keep it. I am struck dumb with amazement.

I really worked hard to resolve this issue through dialogue but Hyun Jin Nim's side absolutely did not engage in dialogue. Honestly, I did not even give a special direction. I did not tell anyone to leave the sanctuary, to come, to go, or to block [Hyun Jin Nim from speaking]. I did not embarrass the young people standing during the sermon or discipline anyone, and just focused on the sermon. I let it be a normal service, and the people in attendance listened attentively. They claim that everyone came to hear Hyun Jin Nim. Of course, I cannot read the hearts of the members.

But I feel. And I know. I know that they didn't just come to hear Hyun Jin Nim speak. If they had really come only because they missed Hyun Jin Nim, then when the continental director started his sermon, speaking about the publication of Father's autobiography and True Parents' textbooks and teaching materials (which had nothing to do with Hyun Jin Nim's visit), the members would not be earnestly taking notes and experiencing God's grace in the service. And, since I felt that the [seated members] were denouncing the students standing on the sides, I know that the hundreds of people who came did not merely come to see Hyun Jin Nim, as they claim.

When Hyun Jin Nim started speaking, members who had in the beginning watched with interest and welcomed [Hyun Jin Nim], gradually started crying and even leaving the sanctuary. This kind of unsettled atmosphere ensued. Hyun Jin Nim's voice kept getting louder, and I perceived that the atmosphere of that place became like being locked up in a secluded room, deprived of freedom of movement.

To put things in order, Young Jun Kim, Jin Man Kwak, Jin Hyo Kwak, Jin Man Choi and In Don Kang were running the show and giving orders but they did not appear in person [before the event]. Only In Don Kang came and went frequently, as a spy to check the situation, giving to me only false information, such as the notification that Hyun Jin Nim would be staying in a hotel [away from the church].

And later they made up a lie that they were waiting and waiting for me to allow Hyun Jin Nim to speak from the podium, but finally decided to enter violently because I had broken my promise [to allow Hyun Jin Nim to speak]. I had made my opinion clear from beginning to end – that I could not allow Hyun Jin Nim to hold a public gathering at the church because True Parents had not allowed it, according to the memo from the international headquarters. Of course, if they were going to push their way in, I would have no choice but to be pushed out. Although the [Brazilian HSA-UWC] board threatened to fire the church president and send him to prison based on corruption, the church president and vice president were determined to follow the [vertical] chain of command.

However, although they started a meeting with a little over 100 members in the 5th floor lecture hall, (after offering a bow to True Parents in Rev. Heung Tae Kim's room, which had been prepared for Hyun Jin Nim) and their supporters told people to come to the 5th floor since Hyun Jin Nim had come, people did not come. Though placards had already been put up and prepared on the 5th floor, [Hyun Jin Nim's

group] left the lecture hall and entered Rev. Kim's room for a short time, prepared to attend Hyun Jin Nim in the sanctuary, then came down unconditionally.

And they made two lines and prepared to attend Hyun Jin Nim. Even when members were asked to sit instead of stand since service was going on, they remained standing, like immobile robots. When Hyun Jin Nim arrived, they shouted and yelled and burst onto the stage, stopping the service in the middle of the sermon.

They have all sorts of false information, claiming that I had promised to attend a True Child but had been disrespectful [by breaking my promise], but I had merely acted based on the memo from the international headquarters which represented True Parents' orders. If I had really planned to attend Hyun Jin Nim despite the memo from the World Mission Headquarters, then I would have gone to the airport and waited for him, then naturally attended him to the sanctuary and respectfully listened to his words. Hyun Jin Nim's arrival was fortunately around 10 am. But I pleaded that Hyun Jin Nim could stop at some place, such as a hotel, and then have a meal or a meeting with leaders. I prepared in this way and requested earnestly that we could do things this way but there was absolutely no response.

It seems as though they had foreseen that things would go as they did, for they had brought over 20 bodyguards to the service. Later on, I found out that they even planned for people who would guard me. Everything was being planned carefully based on Mr. In Don Kang's guidance. They probably were planning to raid the church no matter what and prepared for whatever may be necessary to do so. I found out later that people had been specifically appointed to take me off the stage – people who would guard me and make sure that I did not sustain any injuries. I cannot understand how a True Child could prepare over twenty bodyguards to visit a church, among them some specially trained in martial arts. That kind of preparation was never made for True Parents' visits to churches, or even when True Parents went to extremely remote places such as the Pantanal or the Amazon.

After that, many of those people in attendance [of Hyun Jin Nim's speech] quietly lowered their heads and shed tears. Many filed out of the room when bad language and yelling took place. Although many people had gathered at first, in curiosity, later only half of them remained.

Rev. Myung Gi Shin and the lawyer from the Mission Foundation were with me from the beginning of the service to the end but both of them were extremely shocked at what happened. What is truly heartbreaking is that they consistently used violence and threats and have now made false information into rumors in order to slander the continental director, who was strongly pushing for the implementation of True Parents' directions. They are saying that I promised to attend Hyun Jin Nim, then

broke my promise but stood down when Hyun Jin Nim arrived. They are frantically trying to defame me by spreading false rumors. However, I kept the same consistent stance that Sunday service is when we speak on True Parents' behalf, so Hyun Jin Nim could not speak there unless True Parents and the international headquarters gave permission.

The false information is being spread by UCI people in Latin America and In Don Kang. It is up on Internet bulletin boards frequented by Korean college students. They are even spreading false information around the world in my name. A Chilean studying in Korea asked someone I know if the [Latin American] continental director sent a memo stating that "anyone who goes to Hyun Jin Nim's meeting will lose his/her status as a member of a Blessed Family." I found out that this unimaginable type of rumor was being made to create confusion only after receiving word about it from Korea.

And today, on June 1st, there was a threat made to the national leader that he would be put in jail. I continue to receive threats and violent language as I am being told to leave since I have been fired from my post as continental director.

I am currently discussing matters with the international headquarters. I am dealing with the situation together with the national and vice national leaders in the Brazilian headquarters until Rev. Heung Tae Kim arrives on the third and his schedule in Korea related to the elections is over.

Despite the pain, shock and wounds I received today, I am determining to make a new beginning so that members can become one with True Parents and overcome this difficult situation in unity.

Brazil has been in contact with the international headquarters and Rev. Heung Tae Kim in order to resolve the issue, ever since we found out about it a few days ago. When Rev. Kim arrives on June 3rd, we will work together in one accord to resolve the issue and take care of the members.

What I am worried about is Paraguay.

I am told that Hyun Jin Nim's team will go to Paraguay tomorrow and the day after tomorrow in order to hold Hoon Dok Hwe at the church regardless of whether True Parents give permission or not. They are working to change the members of the board [of HSA-UWC Paraguay?] in order to forcibly transfer the ownership of the Kasado land, owned by the church, to four different companies of which I know nothing about.

However, I am continuously in touch with Rev. Pyeong Rae Moon (who is in Korea), Rev. Sang Pil Moon and Alejandro, whom I dispatched, so that True Parents' orders can be fulfilled. We are praying together with the leaders who came from the field to Asuncion. Latin America determines to protect the altar of True Parents' blood, sweat and tears. Even though it is far and difficult for True Parents to come in person, we will attend True Parents in the center of our hearts more than in any other nation, to become

the flag bearers for the building of Cheon Il Guk.

In closing, I want to thank all those who have been concerned, and I will try to embrace and love even the Latin American members who yelled and cursed at me, calling me the Devil's continental director, with the intent of helping Hyun Jin Nim. While I have toured [the Latin American countries], I always emphasized the spirit of the Pacu fish (which lives in the Pantanal), which is able to swallow baby crocodiles whole, even if they are stained with excremental and filthy water. This spirit, which True Father taught us, can overcome all things – dirtiness, ugliness, evil, vulgarity, betrayal, rage, conflict, division, etc – through one's body, one's life and sacrifice. With that kind of spirit, I will do my best to comfort and overcome the painful wounds in my heart.

Also, I am sorry to Hyun Jin Nim because I think I have given him personal pain because I could not allow him to speak at the pulpit due to providential reasons, though I love him very much. In my mind, I made the decision based on vertical tradition and True Parents' directions but I think I gave big pain to Hyun Jin Nim's heart, which sincerely saddens me. I will offer more devotion for Hyun Jin Nim. And I will try to become a more mature leader so that such things may never happen again.
