This is to announce guidelines for participating in the Blessing Ceremony that will be held to mark the occasion of True Father's 93rd Holy Birthday, True Parents' Golden Wedding and Jubilee Year, and True Mother's *Gohui*. All regional presidents and church leaders should do their utmost best to prepare for the blessing ceremony.

- 1. Name of Blessing: Blessing Ceremony in the Era to Open the Gates to the Victory, Liberation and Completion of the True Parents of Heaven, Earth and Humankind
- 2. Date and Time: 11 AM, 3.03 by the heavenly calendar (March 24, 2012)
- 3. Venue: Cheongshim Peace World Center
- 4. Standard for participation in the Blessing Ceremony
 - 1) Those finalized as a blessing candidate by their regional or national headquarters after having submitted the necessary documents to their national headquarters and passing the relevant screening procedures
- 5. How to participate in the Blessing Ceremony
 - 1) Participate *in person* at the venue of the Blessing Ceremony in Korea
 - 2) For confirmed blessing candidates who are unable to come to Korea: Such candidates should come in person to a venue officially designated and organized by their regional or national headquarters and take part through the live internet broadcast of the Blessing Ceremony in order to receive True Parents' benediction
 - 3) All other methods of 'participation' aside from those defined in 1) and 2) will not be recognized as participation in the Blessing.
 - 4) Thus, any candidate that participates in a location other than a venue officially designated by the respective regional and national headquarters will not be recognized as having participated in the Blessing.
 - 5) For those who are unable to attend the Blessing Ceremony in person or take part in the live internet broadcast, there will be an opportunity to receive the Blessing later through a recording of the main ceremony here in Korea.

Those who view a video recording or other such recordings of the Blessing Ceremony within one week after the main Blessing Ceremony, at a time and venue
