The 59th Session of the UN Commission on the Status of Women (CSW 59), will convene in and around the UN HQ in NY, March 9-20, 2015 with the theme: "*Beijing+20: The Beijing Declaration and Platform for Action.*"

You are cordially invited to attend the WFWPI parallel event which will take place on the first day of CSW 59, on Monday, March 9, from 12:30 to 2:00 pm, in the Armenian Convention Center, 630 Second Avenue, 35th street, New York 10017. The theme is "*Young Women and Leadership: Education, Opportunities and Obstacles.*" Co-sponsors of this event include the World Youth Alliance, Montage Initiative and WFWP USA. It will feature a panel of young women leaders who will address this topic. The parallel event is open to the general public and there is no fee.

You are also invited to attend the annual WFWPI Luncheon which will take place the following day on Tuesday, March 10, from 12 noon to 2:00 pm, in the West Terrace room of the Delegates Dining area, with the theme "*A Celebration of CSW 59 and International Women's Day.*" Mr. Ahmad Alhendawi, Secretary-General's Envoy on Youth, has been invited to speak. Confirmed speakers include Prof. Yeon Ah Moon, President, WFWP International, and Mrs. Carolyn Handschin, Director, WFWPI UN Office. The cost of the luncheon is \$125 per person.

To accommodate guests who will be coming into New York to attend the parallel event and, or, the luncheon the WFWPI UN Office will be preparing a list of recommended parallel events which they may consider attending on these days.

Background Information

United Nations Commission on the Status of Women

Established in 1946, the UN Commission on the Status of Women (CSW) is an intergovernmental body that promotes women's rights, documents the reality of women's lives throughout the world and shapes global standards on gender equality and the empowerment of women.

On an annual basis CSW hosts a two week session at the UN headquarters in New York that includes plenary sessions, forums and parallel events. These activities are attended by representatives of UN member states, civil society organizations, and UN entities, as well as more than 5,000 women participants from around the world.

The 2015 theme for CSW 59 is "Beijing+20: Implementing the Beijing Platform for Action."

Women's Federation for World Peace, International (WFWPI)

The Women's Federation for World Peace International (WFWPI) supports a network of National WFWP chapters in over 120 nations that are dedicated to empower women with "the knowledge, the tools and the support needed to create peace at home, peace in our communities, our nations and throughout the world".
